ARTICLE I -- NAME

The name of the Limited Liability Company is PAJOLE, L.L.C.

ARTICLE II -- ADDRESS

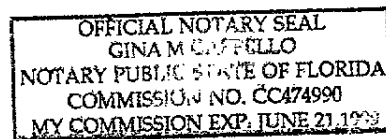
