ARTICLES OF ORGANIZATION

OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE I: NAME

The name of the company is Sandler, LLC (the "Company").

ARTICLE VI: CONTINUITY OF BUSINESS


Upon the death, retirement, resignation or bankruptcy, of the sole Member in the Company, the business of the Company shall not be continued and the Company shall be dissolved.




