ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF GATEWAY FLEX ASSOCIATES, LLC

The undersigned, for the purpose of amending the Articles of Organization of GATEWAY FLEX ASSOCIATES, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.
