TO
ARTICLES OF ORGANIZATION

The undersigned, for the purpose of amending the Articles of Organization of GATEWAY FLEX ASSOCIATES, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

FIRST: The Articles of Organization of GATEWAY FLEX ASSOCIATES, LLC, were filed with the Florida Department of State on December 30, 1998, and were assigned Document Number L98000003478.


SECOND: The following amendment to the Articles of Organization was adopted by GATEWAY FLEX ASSOCIATES, LLC:

Article VIII of the Articles of Organization is hereby amended by deleting the existing Article VIII in its entirety and replacing it with the following:

ARTICLE VIII. MANAGEMENT

The Company shall be managed by a Managing Member, Joanne H. McGarvey, in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
