## ARTICLES OF ORGANIZATION OF JCD COLUMBIAN KNIGHTS, L. L. C.

#### ARTICLE I NAME

The name of the limited liability company is JCD Columbian Knights, L. L. C. (the "Limited Liability Company").

## ARTICLE II EXISTENCE AND DURATION
