ARTICLE I
NAME

The name of the limited liability company is JCD Columbian Knights, L. L. C.
(the "Limited Liability Company").

ARTICLE II
EXISTENCE AND DURATION

The members of the Limited Liability Company shall have the right to admit additional members on the unanimous consent of the members.


ARTICLE VII


