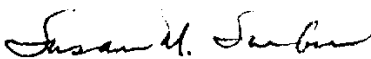

We have received your letter (copy attached) dated May 22, 1998, concerning the administrative dissolution of the above-named corporation for failure to file the 1997 corporate annual report. We have just received this letter as it was apparently lost in the mail and returned to your office; it was mailed again around June 25, 1998 (please see attached letter from Sean Toner).

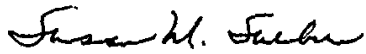
We are writing to respectfully request your consideration in the waiver of the reinstatement fees. First, this corporation has timely filed each of its annual reports and paid the required fees since 1992. The shareholders of this company, Benjamin and Joan Marler, have always acted in good faith to file all documents required by this corporation including annual reports, income and payroll tax returns, and other miscellaneous licensing required as a charter boat owner and operator. This has been true even throughout tremendous financial difficulties resulting mostly from the 1995 hurricanes and an extremely serious accident involving the charter boat. They are still rebuilding and recovering, and the Marlers continue to contribute their personal savings to the company to keep it functioning. Expenses such as this penalty which are not budgeted are devastating to this company.

Finally, the Marlers rely on us heavily to advise them of all filing deadlines, and our office works diligently to ensure all corporate clients have complied with the rules relating to annual corporate reporting. Every year we check with our clients or in their records to be sure the corporate report is filed timely, but this one was apparently overlooked. Additionally, there may have been a problem with the corporation's mailing address. No late notice was received for the 1997 report, and no corporate renewal form was received for 1998 (as we had to adapt a form from a copy of another corporation's report). Perhaps the 1997 form was lost in mailing also.
