

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION OF JEM 8020 CORPORATION



Edmund J. Croteau and Marcel Croteau, as President and Director, respectively, of JEM 8020 Corporation (the "Corporation"), hereby certify that on December 28, 1998, all of the shareholders of Class A Common Capital Stock and all of the Directors of the Corporation approved and adopted the following amendment to the Corporation's Articles of Incorporation:

Article IV shall be and is hereby replaced in its entirety by the following:

ARTICLE IV

Section 1. The maximum number of shares which the Corporation shall have authority to issue shall be 12,000 shares of common capital stock, divided into two classes, the designation and par values of each such class being, as follows:
