**ARTICLES OF ORGANIZATION
OF
MONEY TREE ATM SERVICES, L.C.**

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I (NAME)

The name of this limited liability company is Money Tree ATM Services, L.C. (the "Company").

ARTICLE II (DURATION)

The Company shall have perpetual duration, beginning on the date these Articles of Organization are filed in the Office of the Secretary of State of the State of Florida.

ARTICLE III (PURPOSE)

The Company shall have all of the powers stated in the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as such chapter presently exists and may hereafter be amended.

ARTICLE IV (PRINCIPAL OFFICE AND REGISTERED AGENT)

The street address and mailing address of the Company's initial principal office shall be 12-E Commerce Street, Destin, Florida 32541. The Company's principal office may hereafter be at such other place or places as the members from time to time may determine. The name of the initial

ARTICLE V (MANAGEMENT)

The Company will be managed by one or more managers. Until the first annual meeting of members or until the initial manager's successor is elected and qualified, the initial manager's name and address is:

ARTICLE VI (MEMBERS)

The Company shall not be dissolved but instead shall continue notwithstanding the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event terminating membership in the Company; however, in any such event, a majority in interest of the remaining members (or such greater percentage as may be specified from time to

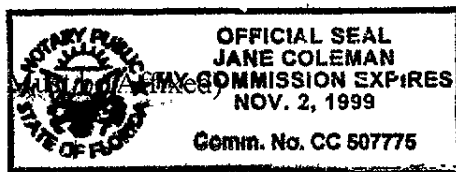




