# ARTICLES OF DISSOLUTION

## OF


### SHIKATRONICS MIAMI, L.L.C.

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

- FIRST:** The name and address of this corporation is **SHIKATRONICS MIAMI, L.L.C.**, 16736 Diamond Drive, Weston, Florida 33331.
- SECOND:** The date of the adoption of these Articles of Dissolution is 27 October 1999.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
