ARTICLES OF ORGANIZATION OF FJS&C INVESTMENTS, L.C.

The undersigned subscribing Members to these Articles of Organization, hereby form a Limited Liability Company under the laws of the State of Florida.

ARTICLE I NAME

ARTICLE II DURATION AND COMMENCEMENT OF EXISTENCE

- A. <u>Dissolution</u>. Subject to the terms of Subsection B below, the Limited Limi

 - 2. Dissolution of any Member who is an entity.
 - 3. Unanimous written agreement of the Members.
 - 4. The number of Members is less than two (2).
- B. Right to Continue Business. Notwithstanding Subsection A above, the non-terminated Members ("Remaining Members") of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company, despite the occurrence of any event which terminates the continued membership of a Member in the Limited Liability Company. The exercise of this right to continue shall be by written notice by any one or more of the Remaining Members (representing at least a majority of the interests in the Limited Liability Company) to the other Remaining Members within thirty (30) days of any event described in Subsection A. of this Article. This Subsection B shall not, however, allow for continuation of the Limited Liability Company if the number of Members at any time is less than two (2).

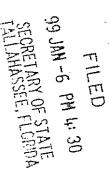

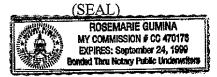
