**ARTICLES OF ORGANIZATION OF  
WESTGATE HOLDINGS, LLC**

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a natural person over the age of 18 years, and being a member or an authorized representative of a member of WESTGATE HOLDINGS, LLC, hereby forms a limited liability company.

**Article 1  
(Name)**

The name of the limited liability company shall be WESTGATE HOLDINGS,  
L.L.C.

**Article 2  
(Duration)**

The duration of the limited liability company shall be twenty five years from the date of filing of these Articles of Organization, which such period may, from time to time, be extended, by amendment to these Articles upon the unanimous vote of members.

**Article 3  
(Initial Principal Office)**

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued

membership of a member in the limited liability company, upon unanimous written consent, the remaining members shall have a right to continue the business of the limited liability company.


Article 7  
(Management)
