**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
HGJ COMMERCIAL PROPERTIES, L.L.C.**

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the undersigned, who are all the members of HGJ Commercial Properties, L.L.C., amend the articles of organization of the limited liability company originally filed with the Secretary of State of Florida on January 13, 1999, as follows:

1. ARTICLE I is hereby amended to read as follows:

**ARTICLE I
NAME**

The name of the limited liability company shall be **Spectrum Properties, L.L.C.**, and its principal place of business shall be in the City of Pensacola, County of Escambia, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

2. The remainder of the provisions of the articles of organization shall remain as filed on January 13, 1999.

The members of Spectrum Properties, L.L.C. (formerly HGJ Commercial Properties, L.L.C.) have executed the preceding amendment to the articles of organization of the company on January 2, 2001.


