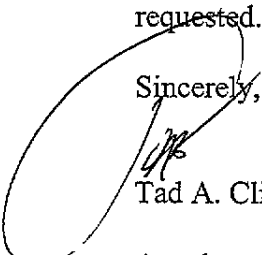

# ARTICLES OF ORGANIZATION OF CLEAR SYSTEMS, L.L.C.

## ARTICLE I Name

The name of the limited liability company ("Company") is CLEAR SYSTEMS, L.L.C.
