


1. The name of the Florida limited liability company is CENTRAL FLORIDA RETINA PARTNERS, L.L.C.

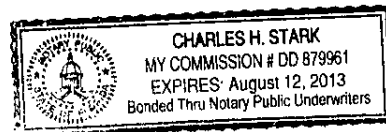
