ARTICLES OF ORGANIZATION

OF

PRIME INVESTMENT, LLC

The undersigned adopt the following Articles of Organization For the purpose of becoming a limited liability company under Chapter 608, the Florida Limited Liability Company Act:

ARTICLE I

Name
