ARTICLES OF ORGANIZATION

The undersigned acting as organizer of MOHLER SWORDS LIMITED LIABILITY COMPANY, under the Florida Limited Liability Company Act, adopt the following Articles of Organization for said limited liability company.

ARTICLE I
NAME

DURATION

This LLC shall exist perpetually, unless dissolved according to law or as set forth in the LLC's Operating Agreement.

MEMBERS AND CONTRIBUTIONS**

**ARTICLE VI

**ARTICLE VII
DISSOLUTION, CONTINUATION**

The members shall have the right to continue the LLC upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or occurrence of any other event which terminates the membership of a member in the LLC, so long as the remaining members agree to continue the LLC.

**ARTICLE VIII
MANAGEMENT**

The LLC is to be managed by a Manager or Managers. The name and address of the initial Co-Managers of the LLC who shall serve as Managers until a successor is elected and qualified are:


