The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

All references in these Articles of InCompany are deemed to include any amendment or successor thereto. Nothing contained in these Articles of InCompany shall limit or preclude the exercise of any right relating to indemnification or advance of attorney fees and expenses to any

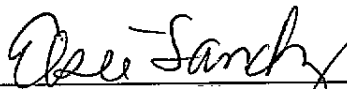

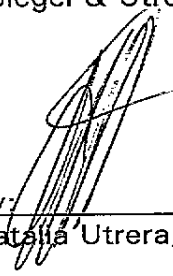
