

# ARTICLES OF ORGANIZATION OF SMJ PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Article of Organization.

### ARTICLE I. NAME

The name of the limited liability company shall be SMJ PROPERTIES, LLC ("Company"). The principal place of business of this Company shall be 1528 Oak Forest Drive, Ormond Beach, Florida 32174.

# ARTICLE II. DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.
