ARTICLES OF ORGANIZATION

The undersigned, desiring to form a Limited Liability Company pursuant to Florida Statutes Chapter 608 hereby state as follows:

ARTICLE I

The name of this Limited Liability Company shall be PETERSON & LAGE, LC.

ARTICLE II

The duration of this Company shall commence when these Articles of Organization are filed with the Secretary of State of the State of Florida until thirty (30) years thereafter, unless earlier dissolved by agreement of the Members hereof, or by operation of law.

ARTICLE III

The purpose for which this Company is organized to own and operate a Florida law firm in the United States, or such other business as the Members may agree from time to time.

ARTICLE IV

The initial place of business of the corporation shall be 6361 S.W. 72 Street, Miami, Florida, Florida 33413 and its initial registered agent for service of process in the State of Florida shall be CORPORATE ACCESS, INC., whose address is 236 East 6th Avenue, Tallahassee, Florida 32303.

ARTICLE V

This Company shall have at least two (2) members and shall be initially capitalized with cash in the amount of TWENTY THOUSAND DOLLARS (\$ 20,000.00), inventory, furniture, and fixtures.

No Member shall be required other than as provided in the Regulations of this Company, to contribute additional capital to the Company.

ARTICLE VI

No Member may be admitted to the Company unless all members affirmatively and unanimously vote to accept the new member(s) under the same duties and obligations of the current members.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member hereof, the remaining members shall have the right pursuant to Regulations adopted by said members to continue the existence of this Company.

ARTICLE VII

This Company shall be managed by a manager. The name and address of the initial managing member is as follows: Gustavo Lage, 6361 S.W. 72 Street, Miami, Florida 33413.

ARTICLE VIII

The power to adopt, alter, amend or repeal the Regulations of this Company shall be vested in the Members of the Company.

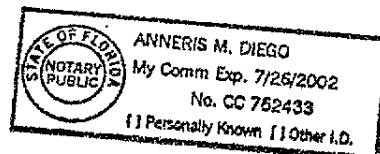
