ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, sets forth the following:

ARTICLE I

<u>NAME</u>

The name of the Limited Liability Company is A AAmerican Trailers, LLC.

ARTICLE II

PERIOD OF DURATION

The period of duration of the Limited Liability Company shall commence five days prior to the filing of these Articles in the office of the Secretary of State of Florida and shall terminate upon the first to occur of the following:

- (i) December 31, 2050; or
- (ii) Dissolution of the Limited Liability Company pursuant to provisions of the Florida Limited Liability Company Act.

ARTICLE III

PURPOSE

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability

Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws, including, but not limited to, the power to purchase goods.

The total amount of cash and/or a description of the agreed value of property other than cash contributed to the Limited Liability Company is as follows: Fifty-Five Thousand and 00/100 Dollars (\$55,000.00). The Limited Liability Company shall have the right to accept additional contributions at any time in the discretion of the managing members.

CLASSES OF MEMBERS

The Limited Liability Company shall have one class and one series of members.

ARTICLE VIII

ADDITIONAL MEMBERS

Members may be admitted upon approval of a majority in interest of the members.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company, the business of the Limited Liability Company shall be continued unless the members elect otherwise.

ARTICLE X

MANAGEMENT
