**Admission of New Members**

Additional members may be admitted only on the written consent of seventy percent (70%) of the existing members, and seventy percent (70%) of the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. Assignment of membership interest may only be permitted with the written consent of seventy percent (70%) of the existing members.

ARTICLE VII

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the written consent of seventy percent (70%) of the remaining members.
