ARTICLES OF ORGANIZATION OF M.E. WILSON CUSTOM STAFFING, L.L.C.

The undersigned member, acting as a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

ARTICLE I

Name 1

The name of this limited liability company is M.E. WILSON CUSTOM STAFFING, L.L.C. (the "Company").

ARTICLE II

Duration of Existence

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State and thereafter shall remain in existence until such time as the occurrence of any dissolving event. Any of the following acts or events shall dissolve the Company: (a) a determination by the members holding a majority of the membership interests in the Company that the Company should be dissolved; or (b) when required by law (each a "Dissolving Event"). The dissolution shall be effective upon the occurrence of any of the above Dissolving Events without any further action required on the part of the Company or its members.

ARTICLE III

Purpose of Organization

The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

ARTICLE IV

Mailing and Street Address; Initial Registered Agent

The Company's initial mailing and street address is 101 South Franklin Street, Tampa, FL 33602, and its initial registered agent is John N. Giordano, whose address is 220 South Franklin Street, Tampa, Florida 33602.

ARTICLE V

Additional Members

The Company shall not admit a new member to the Company without the prior written consent of the members holding a majority of the membership interests in the Company. A member may not assign all or part of such member's membership interest in the Company without first obtaining the written consent of a majority of nonassigning members, and the assignee of a member's membership interest may become a member only if a majority of the nonassigning members consent.

ARTICLE VI

Management of the Company

The Company shall be managed by its members in the manner set forth in the Company's Regulations. The names and addresses of the managing members are as follows:

The power to adopt, alter, amend or repeal the Regulations governing the operation of the Company shall be vested in its members.

ARTICLE VIII

Indemnification

If in the judgment of all of the members, the criteria set forth in §608.4363, Florida Statutes, or any successor statute, have been met, then the Company shall indemnify any member or former member, his, her or its personal representatives, devisees or heirs, in the manner and to the extent contemplated by the §608.4363, Florida Statutes.
