CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF PABLO ROAD, L.C.

SECTE TALLAMASSES

Pursuant to the provisions of Section 608.411, Florida Statutes, the Articles of Organization of Pablo Road, L.C. (the "Company") are hereby amended according to this Certificate of Amendment ("Amendment"):

- 1. The name of the Company is Pablo Road, L.C.
- 2. The date of filing of the Company's Articles of Organization is February 1, 1999.
- 3. Article VIII of the Articles of Organization of the Company is hereby deleted in its entirety and the following language is inserted in lieu thereof:

"ARTICLE VIII - MANAGING MEMBER

The management of the Company shall be vested in the Members. Pablo Road Development, L.L.C. shall act as the Managing Member, having an address at 4314 Pablo Oaks Court, Jacksonville, Florida 32224."

- 4. The members of the Company adopted the foregoing amendment on April 23, 1999. The number of votes cast for the amendment were sufficient for its approval.
 - 5. Except as hereby amended, the Articles of Organization shall remain the same.
