ARTICLES OF ORGANIZATION OF ECKERD/FT. PIERCE ASSOCIATES, L.L.C.

- 1. Name. The name of this limited liability company is ECKERD/FT. PERCES ASSOCIATES, L.L.C. (the "Company"), and the Company shall be formed as a limited liability company under the laws of the State of Florida.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
- 4. <u>Place of Business</u>. The mailing and street address of the Company's principal office in the State of Florida is 405 N. Reo Street, Suite 160, Tampa, Florida 33609.
- 5. <u>Registered Agent and Office</u>. The name of the initial registered agent of the Company is H. Michael Heise. The street address of the initial registered agent of the Company is 3904 Ryalwood Court, Valrico, Florida 33594.
- 6. <u>Additional Members</u>. Additional members to the Company may be admitted, but only upon the consent of all of the members of the Company at the time admission is sought.
- 7. <u>Termination of Membership</u>. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.
- 8. <u>Management of the Company</u>. The Company shall be managed by its members in accordance with the Company's Regulations and Operating Agreement. However, the members shall designate a managing member, which managing member shall have the powers and authority stated in the Regulations and Operaing Agreement. 
