ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I -- NAME

The name of the Limited Liability Company is WANNABE'S, L.L.C.

ARTICLE II -- ADDRESS

ARTICLE III -- DURATION

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV -- MANAGEMENT

The Limited Liability Company shall be managed by a Managing Member. The name and address of the initial Managing Member is **GAUCHITA PRODUCTIONS**, **INC.**, 635 - 17th Street, Vero Beach, Florida 32960. The Managing Member shall be elected annually by the Members in the manner prescribed by regulations as set forth in the Operating Agreement for this Limited Liability Company.

ARTICLE V -- ADMISSION OF ADDITIONAL MEMBERS

The Limited Liability Company shall, with the Managing Member's consent, have the right to admit additional Members upon a vote of a majority of the Voting Units (as defined in the Operating Agreement) of the Members.

ARTICLE VI -- MEMBERS RIGHTS TO CONTINUE BUSINESS

The remaining Members of the Limited Liability Company shall have the right to elect to continue the business of the L.L.C. on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company, by a vote of a majority of the Voting Units (as defined in the Operating Agreement) of the remaining Members.

ARTICLE VII - POWER TO AMEND REGULATIONS

The power to adopt, alter, amend or repeal regulations as set forth in the Operating Agreement of the Limited Liability Company shall be vested solely in the Managing Member.

ARTICLE VIII -- EFFECTIVE DATE

These Articles of Organization shall be effective upon the date of filing.
