### Regulations

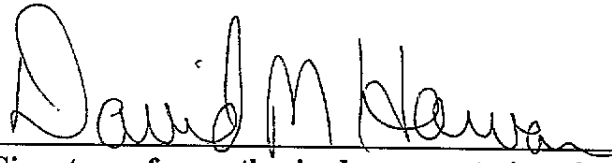
