ARTICLES OF ORGANIZATION

OF

QUALITY DATA COMMUNICATION NETWORKS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I **Name**

The name of the limited liability company shall be QUALITY DATA COMMUNICATIONS NETWORKS, L.L.C. ("Company").
