**ARTICLES OF ORGANIZATION
OF
INTELLIGENT INTERNET STRATEGIES, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. **NAME.**

The name of the Limited Liability Company is INTELLIGENT INTERNET STRATEGIES, LLC (hereinafter referred to as the "Company").

1. **PERIOD OF DURATION.**

The period of duration of the Company shall be from the later of January 1, 1999, or the date of filing of these Articles of Organization, until the first to occur of the following:

- (i) The date that is seventy-five (75) years from the date of filing of the Articles of Organization with the Department of State, State of Florida; or
- (ii) Dissolution of the Company pursuant to the provisions of the Florida Limited Liability Act; or
- (iii) By the mutual written agreement of a majority in capital interest of the Members.

It is the intent of the members that, to the full extent permitted by law the effective date of these Articles of Organization shall be January 1, 1999.

2. **PURPOSE.**

The purpose for which the Company is organized is to engage in and all lawful businesses in the State of Florida and in such other states as the Company and its members deem appropriate. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of Chapter 608, Florida Statutes.

3. **ADDRESS OF PLACE OF BUSINESS.**

The street address of the place of business for the Company is 6429 Kingman Trail, Tallahassee, Florida 32308. The mailing address is Post Office Box 15974, Tallahassee, Florida 32317. Such address may be changed from time to time as provided in the Operating Agreement.

4. **REGISTERED AGENT.**

The initial registered agent in Florida for the Company is Robert James Homme, and the initial registered office is located at 6429 Kingman Trail, Tallahassee, Florida 32308.

5. **INITIAL CAPITAL CONTRIBUTIONS.**

The total amount of cash and a description of the agreed value of property other than cash contributed to the Company is as follows: Two Thousand and No/100 Dollars (\$2,000.00) in cash and Ten Thousand Nine Hundred Ten and No/100 (\$10,910.00) in value of other property is being contributed to the Company.

6. **ADDITIONAL CONTRIBUTIONS.**

The total additional contributions, if any, agreed to be made by all Members (as herein defined) and the times at which, or the events of happening of which, that shall be made, are as follows: No total additional contributions have been agreed to as of the date of filing of

these Articles of Organization. Additional contributions, if any, will be made upon unanimous written agreement of the Members, or as otherwise provided in the Operating Agreement, if any, executed by and among the members.

7. **MEMBERS.**

(a) The Company shall may have more than one class of members. The class of members designated as "Members" shall have all of the rights of members allowed under Chapter 608, Florida Statutes, and such rights, duties and obligations as may be contained in the Operating Agreement. The following persons are the initial Members:

(b) The Company may designate and admit additional classes of members. The designations, rights, privileges and terms of admission shall be determined in accordance with its Operating Agreement (if any).

(c) The Company shall at all times have at least one (1) Member may admit additional Members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement.

8. **CONTINUITY OF BUSINESS.**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

9. **MANAGEMENT.**

Management of the Company is reserved to its Members. The Members may elect a manager in the manner provided in the Operating Agreement. Any such Manager shall have the powers and authority expressly granted under the Operating Agreement. The Initial

Managers are: Robert James Homme and Keith Andrew Sherman, having its principal office at 6429 Kingman Trail, Tallahassee, Florida 32308.

10. **INDEMNIFICATION.**

Except as expressly provided otherwise in the Operating Agreement, the Company shall indemnify any Member or former Member to the full extent permitted under Florida law.
