**ARTICLES OF ORGANIZATION OF
C-CHARTERS, L.L.C.**

David M. Conkle, a natural person competent to contract, presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 9908 Florida Statutes.

ARTICLE I - NAME

The name of this limited liability company is:

C-CHARTERS, L.L.C.

This limited liability company is referred to in these articles as "the Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
