- 1. <u>Name</u>. The name of this limited liability company is CJ MARINA, L.L.C., a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall have perpetual existence from the date of filing of these Articles of Organization with the Department of State.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
- 4. <u>Place of Business</u>. The mailing address and street address of the Company's place of business in the State of Florida is 601 Bayshore Boulevard, Suite 650, Tampa, Florida 33606.
- 5. Registered Agent and Office. The name of the initial registered agent of the Company is Jeffrey B. Meehan.
