ARTICLES OF ORGANIZATION

OF

VENDAPIN, L.L.C.

The undersigned persons, acting as the organizers of VENDAPIN, L. L.C. (the "Company") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopt the following Articles of Organization:

ARTICLE I. NAME, MAILING ADDRESS AND PRINCIPAL PLACE OF BUSINESS

ARTICLE VII. ADDITIONAL CAPITAL CONTRIBUTIONS

VIII. ADMISSION OF SUBSTITUTE OR ADDITIONAL MEMBERS

Additional or substitute members may be admitted only upon the unanimous written approval of the members of the Company in a manner set forth in its regulations.

The manager shall serve in that capacity until the first annual meeting of members or until his successor is elected and qualified.

ARTICLE X. REGULATIONS
