# ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

#### ARTICLE I -- NAME

The name of the Limited Liability Company is BIOZONE SCIENTIFIC, L.L.C.

### **ARTICLE II -- ADDRESS**

### ARTICLE IV -- MANAGEMENT
