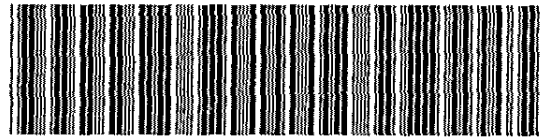

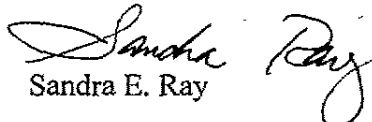

The effective date of the limited liability company's dissolution is May 31, 2004.

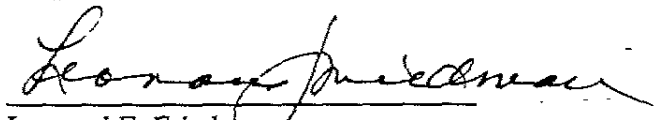
