1. The name of the limited liability company is: SYNTHETIC TURF INTERNATIONAL, LLC.

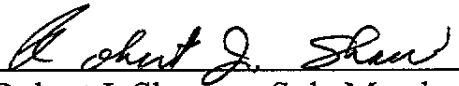
2. Articles of Organization were filed on February 11, 1999 and assigned Document Number L99000000818.
