ARTICLES OF ORGANIZATION ART & SOFT, L.C.

The undersigned, desiring to form a Limited Liability Company under and pursuant to Chapter 608, Florida Statutes, entitled the Florida Limited Liability Company Act (the <u>Act</u>), does hereby adopt the following Articles of Organization for such Company:

- 1. Name. The name of this limited liability company is ART & SOFT, L.C. (the "*Company*").
- 2. **Duration**.
