ARTICLES OF ORGANIZATION OF IVD SOUTH, L.L.C.

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I NAME OF COMPANY

The name of the limited liability company is IVD South, L.L.C. (the "Company

ARTICLE II PERIOD OF DURATION

The Company shall exist in perpetuity, unless dissolved in accordance with the terms of the Company's regulations.
