

ARTICLES OF ORGANIZATION OF EAST COAST NEWS SOUTH, L.L.C.

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I NAME OF COMPANY

The name of the limited liability company is East Coast News South, L.L.C. (the "Company").

ARTICLE II PERIOD OF DURATION

The Company shall exist in perpetuity, unless dissolved in accordance with the terms of the Company's regulations.

ARTICLE III REGISTERED OFFICE AND AGENT
