**ARTICLES OF ORGANIZATION
OF
FLAGSHIP OUTDOOR, L.L.C.**

The undersigned, as an authorized representative of a member of the Company, pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida limited liability company named Flagship Outdoor, L.L.C.

ARTICLE I

Name

The name of this limited liability company shall be Flagship Outdoor, L.L.C. (the "Company").

ARTICLE II

Duration

The period of duration for the Company shall be perpetual.

ARTICLE III

Initial Principal Office

The initial mailing address and the initial street address of the principal office of the Company is 234 East Davis Boulevard, Tampa, Florida 33606.

ARTICLE IV

Initial Registered Office and Agent

The street address of the initial registered office of this Company is 234 E. Davis Boulevard, Tampa, Florida 33606, and the name of the initial registered agent of the Company at that address is Aminie Mohip, Esq.

Right to Admit Additional Members

The members may admit additional members pursuant to a 75% vote of the managing members and the additional terms of the Operating Agreement and/or Regulations of the Company.

Right of Continuation

Upon the death, requirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members of the Company shall have the right to continue the Company.

The Company is to be managed by one or more managers as provided in the Regulations and/or Operating Agreement of the Company. 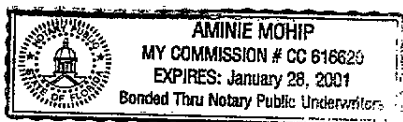

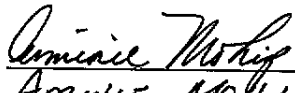
