ARTICLES OF ORGANIZATION

OF

BROWARD INLINE HOCKEY CENTER, LLC

A Florida Limited Liability Company

KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, for the purpose of association to establish a limited liability company for the transaction of business and the promotion and conduct of the objects and purposes hereinafter stated, under the provisions of and subject to the requirements of the laws of the State of Florida, do make, record and file these Articles of Organization in writing.

AND I DO HEREBY CERTIFY:

FIRST:

The name of the Company is:

BROWARD INLINE HOCKEY CENTER, LLC, a Florida Limited Liability Company.

SECOND: The principal office in the State of Florida is to be located at 1402 East Las Olas Boulevard, Suite 1098, Fort Lauderdale, Florida 33301 and the Agent for service of process at said address shall be Bryan Cohen. The Company may also maintain an office or offices at such other places within or outside the State of Florida, as it may from time to time determine. The members and managers of the Company are not liable under a judgement, decree, or order of the Court, or in any other manner, for a debt, obligation or liability of the Company. All expenses incurred by members or managers in defending an administrative, investigative, civil or criminal action, suit, or proceeding, related in any manner to the business of the Company must be paid by the Company as they are incurred in advance of a final disposition of the action, suit or proceeding, upon receipt of an undertaking by or on behalf or a member or manager to repay the amount if it is ultimately determined by a Court of competent jurisdiction, that he or she did not act in good faith, in the manner he or she reasonably believed to be in or not opposed to the best
