

ARTICLES OF ORGANIZATION FOR

EGYED, L.C.

ARTICLE I

NAME

The name of the Limited Liability Company is **EGYED, L.C.**

ARTICLE II

ADDRESS

DURATION/CONTINUATION

Department of State, the period of the Company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the forgoing events.

ARTICLE VI

MANAGEMENT

ARTICLE VIII

POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of the members of the company. This article may be amended from time to time in accordance with the regulations of the Company by a unanimous vote of the members of the Company.

ARTICLE IX

REGULATIONS

The power to adopt, alter, amend or repeal the regulations of the Company shall be vested in the manager unless vested in the members of the Company by an amendment to the Articles of Organization. Regulations adopted by the members or by the manager may be repealed or altered, new regulations may be adopted by the members or manager, and the members may prescribe in any regulations made by them that such regulation may not be altered, amended or repealed by the manager.

AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such terms and provisions prescribed by the Florida Secretary of State, containing such terms and provisions consistent with the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and sworn to by all members or the manager of the Company. In the event a new member is added by such amendment, it shall also be signed by the member to be added.

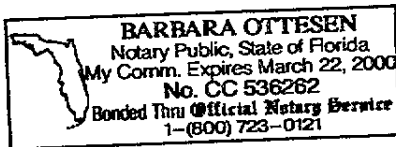

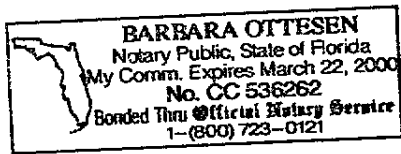


