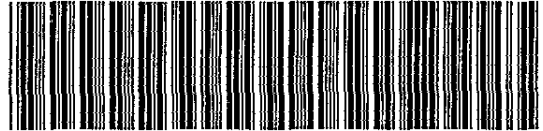

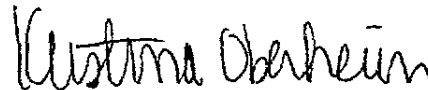

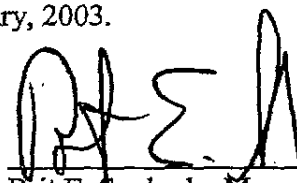

RESOLVED, that the Company's members hereby approve and adopt the attached form of Articles of Dissolution.

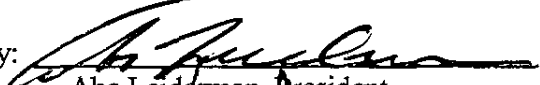
