FIRST AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BURTON MERCER LLC

I hereby file these First Amended and Restated Articles of Organization as the sole member of the limited liability company formed pursuant to Articles of Organization filed with the Secretary of State of Florida on February 18, 1999 and the laws of the State of Florida. The said Articles of Organization are amended to read as follows:

ARTICLE I NAME

The name of the limited liability company to be formed hereunder is BURTON MERCER LLC.

ARTICLE II DATE OF EXISTENCE AND PERIOD OF DURATION

This limited liability company shall begin existence effective the 10th day of February, 1999, or as soon thereafter as these Articles of Organization are filed with the Florida Secretary of State and shall continue in perpetuity, unless sooner terminated in accordance with the Operating Agreement and any Regulations adopted by the members (collectively the "Operating Agreement").
