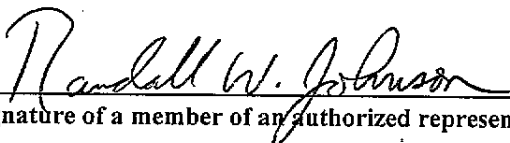
## ARTICLE VI.
