Article 5 All Assets Distributed

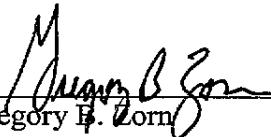
All the remaining property and assets of the Company have been distributed among its members in accordance with their respective rights and interests.
