Article 10. Amendment

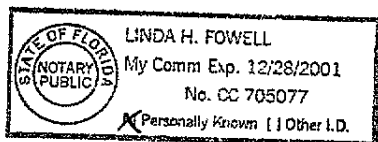

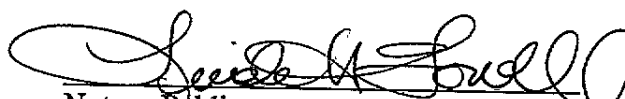

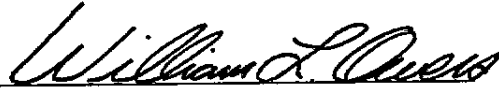

3. The initial amount of cash to be contributed to the limited liability company by the members is \$2,000.00.

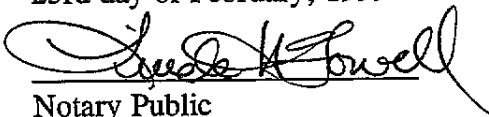

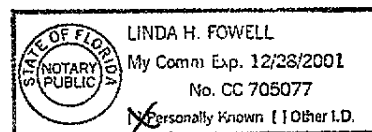
