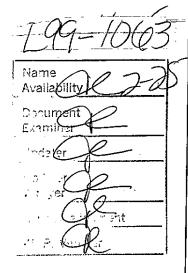

### ARTICLES OF ORGANIZATION

OF

AVALON FLOORING, L.L.C.

THE UNDERSIGNED, PAUL LECHNER, for the purpose of forming a red liability company under the Florida Liability. limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be AVALON FLOORING, L.L.C., ("Company"). The principal office street and mailing address of the Company in Florida shall be: 1719-B Apex Road, Sarasota, FL 34240.

### ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization.

# ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company the case or property set forth in Exhibit "A", attached hereto and made a part hereof by reference.

# ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

# ARTICLE VII - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the written consent of members of the Company holding at least a one hundred (100%) percent interest and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Regulations of the Company, but the transferee shall have no right to participate in the management of the business and the affairs of the Company unless members of the Company (other than the member proposing to dispose of his or her interest) holding at least a one hundred (100%) percent interest approve the proposed transfer by written consent.

# ARTICLE VIII - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion or bankruptcy of a member or manager, or upon the occurrence of any other event that terminates the continued existence of the Company, unless the Company is continued by the consent of all the remaining members, provided, however, there must be at all times at least two (2) remaining members.

#### ARTICLE IX - MANAGEMENT

Management of the Company is reserved to the members in accordance with Operating Regulations adopted by the members form time to time for the management of the business and affairs of the Company. The Operating Regulations adopted by the Company may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with Florida law or these Articles of Organization.
