AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
CT FUND SERVICES, L.L.C.

The undersigned do hereby execute, acknowledge and file the following Amendment to the Articles of Organization of CT FUND SERVICES, L.L.C.

1. The name of the Limited Liability Company is currently CT FUND SERVICES, L.L.C.

2. The date of the filing of the Articles of Organization was February 25, 1999.

3. The Articles of Organization are amended as follows:

a. By deleting all of Article I, and by substituting in lieu thereof, all of the

following:

The name of the limited liability company shall be "CT INVESTMENT STRATEGIES, L.L.C." (the "Company") and its principal place of business and mailing address shall be 7850 N.W. 146th Street, Ste. 436, Miami Lakes, FL 33016, County of Miami-Dade, State of Florida. The Company shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

b. In all other respects, the Articles of Organization shall remain unchanged.

4. This Amendment was adopted by a written statement signed by the sole member of CT FUND SERVICES, L.L.C. to be known hereafter as CT INVESTMENT STRATEGIES, L.L.C. on June 1, 1999, pursuant to Section 608.411 of the Florida Statutes.

5. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Organization with the Secretary of State of the State of Florida.

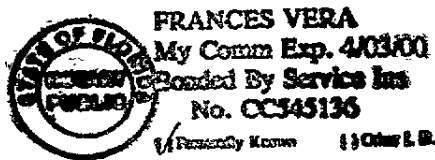
