ARTICLE VI – Indemnification:

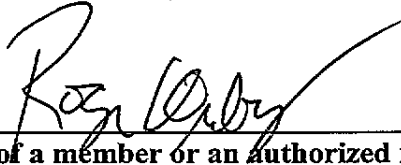

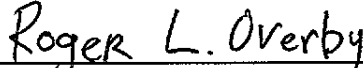
