The undersigned, intending to form and create a Limited Liability Company, as defined in Chapter 608 of the Florida Statutes, hereby states:

1. Name. The name of the Limited Liability Company shall be L. A. PROPERTIES OF JACKSONVILLE, L.C.
2. Duration of Company. The company shall have perpetual duration.
3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 6100 Kennerly Road, Jacksonville, Florida 32216.






